





1. India Day 2023 will be held at Eisemann Center, Richardson TX on Sunday, January 22nd, 2023.



12. Sending an e registration portal entry form is not an automatic acceptance to perform at India Day. Entries will be confirmed by the India Day committee upon verification of data.
13. Solo performances will not be accepted. Each performance must have a minimum 10 participants with a maximum of 20 participants including choreographers and assistants.
14. Each performance can have a single Choreographer and an assistant if needed; An additional assistant can be added to the team, if there are more than 12 participants in a performance.
15. No performer will be allowed to participate in more than one performance.
16. Minimum age to participate is Six (6) years at the time of submission.
17. Due to the nature of the program, no live vocal or music for dance performances will be accepted. Only pre-recorded audio recordings will be accepted as background music for the performance.
18. Each performance cannot exceed 4 minutes 30 seconds
19. Repetition of songs in performances is not allowed. Similar performances will be selected on a 'First-Come-First served' basis.
20. We encourage themes that are fast paced Folk, Regional, Patriotic, Semi-classical and Movie song performances appropriate for the family event.
21. Dance schools submitting multiple entries must have each performance submitted in a different theme.
22. Performers are not allowed to wear glass accessories or use props that can shatter, break or leave residue on the floor, e.g. trinkets, jewelry that can break easily. No stickers, tapes or markers on stage.
23. All participants, including Choreographers and their assistant(s) will be given complimentary non-transferrable wristband/entry-pass to attend India Day. Their complimentary seats will be reserved in a particular section.
24. All Participants who want to sit outside of their reserved section before/after their performance, must buy tickets
25. All participants will be provided complimentary beverages and snacks after their performance.
26. All participants must report to the back-stage coordinator on Sunday, Jan 22nd, 2022 at Eisemann Center by their specified reporting time
27. For a smooth flow of the INDIA DAY program, your cooperation is highly appreciated.
28. Eisemann Center is going to have PAID PARKING and carpooling is encouraged.
