## **General Guidelines for all Food & Non-Food Booth Holders**

- All booth holders must begin booth setup at 12:00 pm on Saturday, August 12, 2023. Enter from Diamond Dr or Rough Riders Trail to park and unload your vehicle at the designated Vendor Parking Area. This entrance will close at 3:00 pm for the booth set up.
- Per Frisco Fire Marshal's ruling, no vehicles are permitted inside the Rough Riders Arena or near the Booth Area.
- · Booth Holders will get a parking pass to park at the Vendor Parking area.
- All Booths will have to <u>close at 10:00pm</u>. Waste oil and other materials are to be disposed of properly. At the end of the event, please proceed with your belongings to the designated Vendor Parking Area.
- A security deposit of \$300 for food booth vendors and \$150 for non-food booth vendors is to be paid before the event along with the fee for the booth. This amount is refundable within 30 days of the event based on fulfillment of certain conditions as listed below:
  - (i) All vendors are required to keep their booth and surrounding area neat and clean at all times. All paper, waste oil and other trash/materials must be disposed of properly at the appropriate receptacles at the Roughriders Stadium.
  - (ii) The Stadium authorities have strict rules on clutter and waste left behind at the venue, therefore, vendors are required to leave the booth in the same condition as it was given to them.
  - (iii) Please make sure that all your belongings are removed before you leave the venue.
  - (iv) If the designated booth area is not clean then IANT reserves the right to forfeit the entire or a portion of the security deposit amount.
- Underwriter/Grand/Presenting/Platinum/Corporate/Gold & Silver Sponsors will be awarded first choice to select the booths. The remaining booths will be allocated in the order of when complete payment was received. Do not use booths other than ones specifically assigned to you.
- Sub-leasing or sharing of booths with others is NOT allowed.
- · Booth fees once paid are Non-Refundable.
- · Bring a Trolley or make your own arrangements to assist in loading and unloading your belongings.
- No piercing, stapling, or making holes on the tent or frills or facility structure are allowed. You are responsible for any dues to the Vendor in case of damages.
- 110V power outlets will be provided in your booth. Don't use more than 3,000 Watts of electric load. Bring your own 50' Heavy-duty extension cord and strip with surge protector fuse. There will be basic lighting available in the booths. Feel free to bring your own in case you need more.
- Given the large crowds expected, it is best to bring your own Mobile Hotspots to conduct Internet transactions from your devices.
- Booth holders are permitted to bring water/beverages for booth holder's consumption only. See restrictions below on selling beverages.
- · IANT & Rough Rider has exclusive rights to sell bottled water at this event.
- Food booth vendors are NOT permitted to sell alcoholic or any other beverages like Soda, Lemonade, Iced tea except Indian traditional Indian drinks like Chai, Lassi or Shikanji etc.
- Flyers, promotional activity or materials distribution is permitted only from your assigned booth.
- Distributions of any materials in the Frisco RoughRiders BallPark premises/parking lot(s) by vendor(s) or person(s) not authorized by IANT is strictly prohibited and is subject to fines and removal from the premises.
  IANT reserves the right to approve/disapprove your publicity material.
- Holding of paid raffles/lotteries in Frisco RoughRiders BallPark grounds is strictly prohibited.
- There will be no refunds in the unlikely event of cancellations due to acts of God, including weather related cancellations and cancellations due to facility complications.

## DISCLAIMED: HOLD HADMLESS:

Booth Holder hereby agrees to save and keep, its agents, representatives, sponsors and employees, THE INDIA ASSOCIATION OF NORTH TEXAS, and the ROUGHRIDERS STADIUM, harmless without limit without regard to the cause or causes thereof or the negligence of any party or parties whether such negligence be sole, joint, contractual or concurrent, active or passive, or gross negligence, and by insurance to indemnify IANT, its agents, representatives, sponsors, and employees from and against any and all loss, cost, expense, liability or damage including punitive or exemplary damages and including any and all damages or liability, or judgment resulting from the serving food and for beverages, and any and all other claims, demands, or liability, or judgment, by or to the general public, employees/members of booth holders, or bystanders, on account of or occasion by AND WHETHER DUE TO THE NEGLIGENCE OF IANT, ITS AGENTS, REPRESENTATVES, SPONSORS AND EMPLOYEES THAT ALL IANT OBLIGATIONS BE WITHOUT LIMIT AND WITHOUT REGARD TO THE CAUSE OR THE NEGLIGENCE OF ANY PARTY OR PARTIES, WHETHER SUCH NEGLIGENCE BE SOLE, JOINT, CONTRACTUAL, OR CONCURRENT, ACTIVE OR PASSIVE, INCLUDING GROSS NEGLIGENCE, OR OTHERWISE, the construction, repair, alteration, maintenance, operation, or any use, made of facilities, dismantling of or removal from the premises of booth holder's facilities and equipment or any loss due to fire, theft, burglary, malicious mischief, or accident.

## HOLD LIABILITY

Booth Holders agree that neither IANT nor its agents, servants or employees shall be responsible or liable for any claim by the booth holder for personal or business injury to the booth holder, its agents, servants, or employees, or for loss, theft or damage to property of the vendor, its agents, invitees, servants or employees during the term of this agreement, from any cause whatsoever by reason of use, occupation and enjoyment of event site by booth holder or any person thereon with the consent of the booth holder. IANT shall not be responsible for damage to the booth holder's business or any other losses incurred by the booth holder in the event that the IANT is unable to provide event space or to hold the event as scheduled. At the termination of the event, the vendor shall at once surrender the event space to the IANT, in as good repair and condition as at the commencement of the booth holder's use of the space. Reasonable wear and tear is expected.
